President's Report

Happy 30th anniversary to FOAH! The Friends group was formed on 14th November 1988. Our history shows what remarkable outcomes have been made to conserving and promoting the natural and built environment within Anstey Hill Recreation Park.

Our last gathering was last Sunday, 11th November at 2 pm to celebrate this wonderful milestone. The event occurred at the Tea Tree Gully Heritage Museum, Perseverance Road at Tea Tree Gully. Afternoon tea was catered for by volunteers at the museum. Grant Pelton, Acting Group Director, Parks and Regions, DEW, with the assistance of Nick Purdew, Anstey Hill Ranger, presented letters, certificates and badges from Minister David Spiers to those who had been FOAH members for 30, 25, 20 and 10 years. We were fortunate to have Roy Manning, inaugural FOAH President attend the event and Roger Collier who is a 30 year member and continues to assist at weekly working bees and has re-joined the FOAH committee. Letters of congratulations were received from the Minister and also John Schutz, Chief Executive, DEW. Thank you to Christine Thomas, FOAH secretary for assisting with the anniversary preparations. Thank you also to members and friends who attended or sent congratulatory emails. Frances Bedford MP attended earlier and received her letter, certificate and badge and presented us with a donation.

Mary Lane has checked out the planted enclosures and is not convinced that they are a good idea, as the plants disappear as soon as the fence goes down. She suggests we go back to only using tree guards for 2019. Mary has suggested that FOAH do a bit of a renovation at the Look Out including "putting up a new sign, perhaps new seating, and possibly widen the track to it from Ridgetop Walk, so that we can get a car and trailer up there to take up mulch, tools etc more easily. A further idea would be putting in a new path straight down from the Look Out with a few "natural" steps following the present "goat" track." Mary is happy to come to our next committee meeting to discuss her suggestions and realises that these renovations would need to be done in consultation with Nick and DEW.

The fire crew have been in the park carrying out fire prevention behind the shed on the western side adjacent to the track. They carried logs into the shed for us to create a native bee hotel in the park. We decided we will name it '**Graham's Hotel**', after Graham Fisher, as it was his idea!

Our Volunteer Support Officer, Amy Anderson, is offering to conduct a 'Bush Regeneration Workshop' for FOAH volunteers this year. Please consider this offer and let me know if you are interested.

FOAH were invited by the Tea Tree Gully Museum to have a stall at their 'Spring in the Garden' event on 21st October. Thank you to members who assisted on the day.

We will need to look at improved marketing opportunities to further promote FOAH, for example, purchasing a banner.

On Wednesday 21st November I am attending the last of the FOP's President's workshops to finalise a draft Board business plan that mainly reflects member's priorities for the organisation into the future. A final draft plan will then be posted onto the Friends website for information and feedback. The objectives of the business plan are to ensure that the FOP's organisation remains responsive to a changing business and market place, and that it continues to be reflective of community values and expectations, while maintaining a strong focus on supporting DEW.

Park Report

Since the last report the Wednesday Working Group has continued the ongoing tasks of weed removal in particular olives, boneseed and cape tulip The work has also included the removal of tree guards (where appropriate), graffiti and fencing.

Staff from Laureate University have committed to volunteer with the group on Wednesday 21 November.

Amy Anderson (Volunteer Support Officer – Central District) will be approached to see if personal protective equipment and spray bottles can be provided for working group use.

Sorting of files continues. The library is almost complete with one more cupboard of files to sort through and cataloguing of photos to be done.

Since the last report 144 hours have been worked with an average application of 20.5 hours/morning. Average number of volunteers each session has been 7.




Membership Renewal

Looking Back on 30 Years Service

The Friends of Anstey Hill's 30th anniversary was celebrated at the TTG Heritage Museum, Perseverance Rd. on Sunday 11 November, 2018. Lea has already made reference to some highlights of the afternoon in her report which appears on pages 4 - 6 of this Newsletter.

In opening the meeting Lea welcomed:

- Frances Bedford State Member for Florey, a long-time member and supporter of FOAH. Frances attended early as she had another function to attend. Thank you to Frances for your generous donation to FOAH.
- Department for Environment and Water (DEW) representative Grant Pelton, Acting Group Director, Parks and Regions, Stuart Paul, our ranger Nick Purdew and Pam Smith, Grants and Volunteer Program Administration Officer.
- Members and volunteers past and present, some of whom have committed many hours since 1988, including inaugural President Roy Manning and Roger Collier.

David Speirs, Minister for Environment and Water, sent a letter to FOAH congratulating us on 30 years of valued community service and stated that he appreciates the contribution by members to reach this significant milestone while helping to conserve our state's natural and built heritage. The Minister added that the continued support provided by FOAH will ensure that this area remains a valuable and protected region of South Australia for future generations to enjoy.

Chief Executive of DEW, John Schutz also sent a letter in which he congratulated FOAH on "30 years of invaluable service to the Anstey Hill Recreation Park". He added that "Volunteers make an enormous and valued contribution to projects across South Australia, helping to conserve the environment and manage our natural resources and heritage sites, and in our wonderful National Parks. The significant contributions made by members, both past and present, has helped to sustain the Region's biodiversity as well as maintain a strong community connection to these valuable natural environments. He thanked all for playing a part to help ensure that Anstey Hill Recreation Park remains a valuable part of South Australia's system of parks and reserves, for current and future generations to enjoy."

Thank you to Gill Starks, President, Tea Tree Gully Heritage Museum and her team for catering for our celebration. As I mentioned at our 25th anniversary, it is important to establish partnerships and engage with likeminded community organisations and their volunteers – it creates community ownership within regions.

Let us reminisce again to 1988:

The Inaugural Meeting was held on 14th November 1988 with over 100 people attending. Dene Cordes, Community Liaison Officer for National Parks and Wildlife Service spoke about the importance of community support. Anstey Hill was dedicated on 17 September 1989 as a Recreation Park with a budget of \$10,000.



The inaugural committee included President Roy Manning, Angela Stuart, Secretary, and Patron Di Gayler, M.P.

It is worth mentioning again that an article in the Leader Messenger of 2 November 1994 had its headline article titled:

"Mystery trio wants to develop restaurant, monorail and Hahndorf-style village. \$100m 'vision' for Anstey Hill".

The developers stated that the plan would not go ahead without the approval of the Friends of Anstey Hill. We know the result of that communication.

It is a pleasure to volunteer alongside such dedicated people who have a passion for conserving the natural environment. Changes in the park environment have been quite remarkable over the past 30 years thanks to dedicated staff and volunteers. With working bee members wearing FOAH work shirts and also a large sign on our trailer, more visitors are aware of the work carried out by volunteers in the park.

It must be noted that one of South Australia's significant cultural heritage sites, Water Gully, originally owned by the Newman family, lies within Anstey Hill Recreation Park. Some original plants including a camellia tree, survive at the site. Care will need to be taken to contain the spread of the introduced plants further into the park.

Wednesday morning working bees continue each week come rain or shine. Most of the work carried out has been to eradicate olives with pleasing results in many areas. The department's Weed Management Plan highlights the priority areas in which volunteers can work.

Events that have occurred in the park this year include major mountain bike competitions, a few weddings in the quarry area of the park and regular bush kindy sessions. It is encouraging to see teachers educate children within a local natural environment.

Grant Pelton, Acting Group Director, Parks and Regions, DEW, with the assistance of Nick Purdew, Anstey Hill Ranger, presented letters, certificates and badges from Minister David Spiers to those members present at the 30th anniversary who had been FOAH members for 30, 25, 20 and 10 years.
